FOR SOME THIS MAY MEAN RECEIVING HELP IN RECOVERING MISSING IDENTIFICATION DOCUMENTS OR HELP WITH LEARNING HOW TO BUDGET. CASE MANAGERS HELP FAMILIES NAVIGATE THE RENTAL APPLICATION PROCESS AND HELP THEM UNDERSTAND HOW TO BE GOOD TENANTS.

AN ASSIGNED CASE MANAGER CHECKS IN REGULARLY TO ENSURE FAMILIES ARE ON TRACK AND ARE NOT EXPERIENCING HARDSHIP OR NEW BARRIERS. MANY OF OUR FAMILIES DO NOT HAVE A FAMILY OR COMMUNITY SUPPORT SYSTEM. WE CAN HELP THESE FAMILIES BECOME SELF-SUFFICIENT AND INTEGRATE IN THEIR NEW COMMUNITY. AT TIMES FAMILIES MAY NEED RENT OR UTILITY ASSISTANCE, TRI-MET PASSES, OR DIAPERS/WIPES. OUR CASE MANAGER HELPS KEEP OUR GRADUATES ON TRACK WITH THEIR HOUSEHOLD BUDGETS MAKING SURE RENT EATS FIRST.
